Member Mok:

Welcome Alan! We are happy to have you here.

Safety and security is the utmost importance of the students and staff in the District. It is 100% clear

Addressed comments made by speakers: Yes, we are attorneys. To be clear, a woman has a 5 year restraining order against her. It was imposed by a judge, not by us. That is what is at issue here.

We have periods where we deal with challenging issues under difficult circumstances and we have to make difficult decisions, but I am happy to see how this District operates under these challenges.

Had the opportunity to go to Strategic Design Meetings which is the implementation phase of our Strategic Planning Process. It is where we translate our ideas and our vision into action. Couldn't have been more excited to have been there and see the work that the team was doing. It was really exciting to hear about the ideas that came out of that meeting. Everyone collectively worked and everyone contributed with their own unique lens, working together to reach a common understanding. Everyone was respectful, engaged and productive. People in this district deeply care about providing the best education possible for the children in this community. They embrace a culture of care and respect where everyone is treated as an individual and their ideas are respected and valued. We use the best resources to find the best teachers and create student centered environments to support how each individual student can learn best. I am extremely proud of this District. The vision I have for this District is to harness the strengths of everyone to create an incredible educational experience for every child in this District that we can all take pride in. We are already an exceptional district in so many ways, but we are only climbing higher.

## Member Rafner:

## Member Kholos:

## Member Fitzpatrick:

Welcomed Alar Kholos back to the Board and hoped he changed perspectives on certain issues over the years. It is hard for me to sit here with a Trustee who voted against TK and defund that program back in 2015, which is almost a decade without the program. Our 4-year olds in the community do not receive benefits from that program while the rest of the state is implementing it for all 4-year olds and only 5 Districts are not at this point. In a matter of month, there will be a PreK to 3 - new credential to the credentialing program so that teachers can be well prepared to teach TK. It is a train that has left the station and is not stopping and our District is continuing to not implement a program that is well deserved by our communities youngest learners.

I also appreciate the emails regarding school safety. I work in a district that is already locking doors - it's commonplace and I question why our

District lags behind on such implementations. If we are the forefront in thinking - we aren't showing it.

I attended one of the Strategic Design Meetings - I had to bring my 4 year old as there was no child care. We would get a lot more community engagement if we had child care or had the option to attend virtually. We should still be able to offer our feedback if we are unable to attend in person. There is no place on the website to give feedback or find out what is going on at these meetings.

In this day and age, there is so much that can be done collectively, virtually that is just as productive and worthwhile.
