Procedural, Report: 4.2 REPORT OF ACTION TAKEN IN CLOSED SESSION Governing Board Halpern reported the following action taken in Closed Session:

The Board met in Closed Session to discuss the judgment and writ issued by the Court in the Del Mar Heights Rebuild Project. The Board reviewed the options that were specified by the Court for the District to complete its environmental analysis. The Board considered the potential for a second Mitigated Negative Declaration, a focused Environmental Impact Report, or a full Environmental Impact Report. The District needs to address the two remaining environmental issues related to temporary construction noise and biological resources. The Board has determined that it is in the District's best interest to undertake the preparation of a focused EIR which will allow a thorough, full, and complete review of the issues identified by the Court and hopefully avoid any further litigation delays. The decision to proceed with the focused EIR was unanimous in a 5-0 vote. The court documents will be posted on the District's website.
