



## **Pesticide Spraying Notification**

**Del Mar Union School District**

Dear Parent or Guardian,

The Healthy Schools Act of 2000 requires all California school districts to notify parents or guardians of pesticides they expect to apply during the school year. The district office and school sites may be treated with the following **ECO-friendly products** and pesticides as needed.

CB-80 Extra	Pyrethring, Piperonyl Butoxide
Wisdom TC Flowable	Bifenthrin
Flatline Soft Bait	Chlorophacinone
Gopher Scram*	Clove Oil, Garlic Oil, Linseed Oil, Rosemary Oil
Snake Scram*	Clove Oil, Cedar Oil, Cinnamon Oil, Rosemary Oil, Garlic Oil
Pro-Pell Rodent Repellent*	Soybean Oil, Peppermint Oil, Rosemary Oil
Essentria ICPPro*	Sodium Lauryl Sulfate, Geraniol, Clove Oil, Commint Oil
Advion Ant Gel Bait	Indoxacarb
Essentria G*	Clove Oil, Thyme Oil, Corn Cob, Wintergreen Oil

\*These chemicals are exempt from notification regulations established by CDPR 25(b). This information is provided voluntarily by the Del Mar Union School District.
