The agreement also states that the Assistant Superintendent of Instructional Services will be paid an annual salary of \$191,000,00 for the 2023-2024 school year. The Assistant Superintendent of Instructional Services is eligible to receive a \$5,000 stipend for an earned Doctoral degree, if applicable. After completing four (4) years of service as Assistant Superintendent, starting in the fifth year of service, the Assistant Superintendent of Instructional Services will also be eligible to receive an annual longevity stipend equal to four percent (4%) of her annual contract salary. In addition, the Assistant Superintendent of Instructional Services will receive the health and welfare benefits which are provided to the Districts administrative employees at an annual cost to the District of \$13,500. Other fringe benefits included within the Assistant Superintendent of Instructional Services

agreement include 12 sick days, 25 vacation days per year, and reimbursement for professional growth activities, travel and actual and necessary expenses while performing day-to-day duties for the District in accordance with Board Policy.
