  - 2014 Initial Plan
  - 2018 Plan Updated

- Modern Learning Studio Pilots
  - Upper grade Pilots Begin 2015
  - Primary Pilots Begin 2017





### DEL MAR HEIGHTS REBUILD - PROCESS



COALS

Defining the desired outcome that supports the strategic direction for the project.

FAUIS

Given information identified as having objective reality influencing the project outcome.

NEUS

Define the scope of work necessary to meet the strategic goals of the district.

CONCEPTS

Development of concepts & approaches to meeting the identified needs of the campus.





SYMPOSIUM OVERVIEW

- Spring 2019 5 community planning meetings
  - Community, staff, and district input
  - Goals, Facts, Needs, Concepts
  - Started with no design
  - Input and priorities shaped design
- Fall 2019 2 community input meetings
  - Shared design updates and gathered input
  - Responded to input and feedback

### DEL MAR HEIGHTS REBUILD – BEING A GOOD NEIGHBOR

### Adjustments Made (not an exhaustive list)

- Reduced roof heights
- Increased field size (2 times)
- Met with neighbors regarding trees and landscape next to Mira Montana
- Moved buildings to the east, improving views (2 times)
- HVAC at ground level rather than rooftop
- Investigated green roofs, retaining walls, and alternative plans

### DEL MAR HEIGHTS SCHOOL REBUILD – MITIGATED NEGATIVE DECLARATION

- A Negative Declaration, Notice of Exemption (NOE), or a Mitigated Negative Declaration (MND) is commonly utilized for a rebuild
- Similar projects in neighboring Districts:
  - Sunset HS (San Dieguito USD) Negative Declaration
  - Earl Warren (San Dieguito USD) MND
  - Skyline (Solana Beach SD) MND
  - Solana Vista (Solana Beach SD) MND
  - La Costa Meadows (San Marcos USD) MND
  - Alvin Dunn Elementary/La Mirada Academy K-8 (San Marcos USD) NOE

### DEL MAR HEIGHTS SCHOOL REBUILD – CEQA

- Initial Study-Proposed Mitigated Negative Declaration released 2/20/20
- Public review through Monday 3/23/20
  - Extended to Monday 3/30/20
- Notice of Intent posted
  - Del Mar Heights School
  - Del Mar Hills Academy
  - DMUSD District Office
  - District website

### DEL MAR HEIGHTS SCHOOL REBUILD – CEQA PUBLIC COMMENTS

- 27 total comment documents submitted
- II multi-page comments submitted (typical length 2-7 pages)
  - Play Outside Del Mar 55 pages
  - Procopio on behalf of Save the Fields 61 pages
- Transmitted to State Clearinghouse for review by state agencies
  - No state agencies submitted comments
- Therefore, no report or board action at this meeting

## DEL MAR HEIGHTS SCHOOL REBUILD – CEQA RESPONSE TO COMMENTS

- Thorough response
- Review of all comments
- Further study as necessary to understand and evaluate potential impacts based on comments received
- Board review upon completion
- Potential Board action

### DEL MAR HEIGHTS SCHOOL REBUILD – DSA PRE-CHECK

#### **DSA Pre-check Process**

- NOT the submittal of the project to DSA
- NOT a binding step
- DID NOT come at a cost to the District
- IS a standard step for any project this size
- IS an opportunity to receive input that can help to improve the project
- IS proactive planning for the project

### DEL MAR HEIGHTS SCHOOL REBUILD – DISTRICT OBJECTIVES

- Improvements: safety and security, energy efficiency, traffic and queuing, indoor and outdoor learning spaces, and outdoor play areas and fields
- Receive stakeholder input and respond with plan revisions/updates
- Follow environmental standards and beyond
- Fiscal responsibility
  - Ensure facilities funding makes the greatest impact possible
